## Langley certified as CLEO/Thurgood Marshall Associate

Durham, NC - DeWarren K. Langley was selected to attend the 2008 Council on Legal Education Opportunity (CLEO)/Thurgood Marshall Attitude is Essential (AIE) Pre-Law Seminar held July 11 - 13 at the Renaissance Concourse Hotel in Atlanta, Georgia and certified as a CLEO/Thurgood Marshall Associate. As a certified CLEO/Thurgood Marshall Associate, Langley is eligible to receive academic support services and stipends.

CLEO/Thurgood Marshall Attitude is Essential (AIE) Pre-Law Seminar is federally funded through a grant from the U.S. Department of Education and designed to familiarize students who are already admitted to law school with the demands associated with the first year of law school and to acquaint them with resources available to help them meet those demands. The workshop sessions and accompanying handout materials cover such topics as legal analysis and writing, legal education financing, debt management, class preparation, the Socratic Method, case briefing and so forth.

Langley says, "AIE was a realistic exposure to the study of law while affording me the opportunity to learn a wealth of knowledge which will prove to be invaluable in the fall."

In August 2008, Langley will be a first year law student at North Carolina Central University School of Law (Class of 2011). He also plans to earn a Certificate in Dispute Resolution from the Dispute Resolution Institute at NCCU School of Law.
